Covenant between an Outreach Team and the New York Mennonite Conference

This Covenant is between <insert team name> ("Team") and New York
Mennonite Conference ("NYMC")

- Term of this Covenant NYMC and Team agree that this Covenant will be in effect until both parties agree
 that the Outreach or Church Planting work described in the Team's application is complete or until both
 agree that the work cannot be completed. The parties will signify such agreement by signing the Completion
 section at the end of this Covenant.
- Funds. NYMC agrees to provide funds in the amount of <insert the amount> to the Team for the Outreach
 or Church planting activity described in the Team's application <modify if scope is modified after the
 application>.
- Use of Funds. The Team commits to using the funds in ways that reflect the standard of Christian stewardship including:
 - a. Funds will be spent consistent with the plan included in the application
 - b. No funds will be used for salary or payments to any team member or other member of the Conference unless explicitly described in the application or in this Covenant
 - c. Any funds that remain after completion of the work described in the application will be returned to NYMC for use by other teams or congregations through the Outreach and Church Planting Fund.

 - a. The current status of the Outreach or Church Planting work, including any significant progress or obstacles occurring since the most recent report.
 - b. The plans for the Outreach or Church Planting work during the next six to twelve months
 - c. A summary of spending to date and plans for spending over the next six months
 - d. If NYMC is contributing to the project in installments, each update should include an updated installment
 - e. If the Team indicated in their application that they anticipated returning some or all of the funds to
